## SPORTS HALL OF FAME GUIDELINES

## Martin Methodist College

- 1. Nominees may be living or deceased, and may be an entire MMC intercollegiate team as a whole (not as individual members).
- 2. The nominee must be an alumnus or alumna or other person who has had a significant impact or has brought special recognition to athletics at MMC.
- 3. Living nominees must not be in the employment of the college, except in extraordinary circumstances, and must have finished playing at Martin Methodist College for 10-years.
- 4. The number of individuals inducted each year shall be held to two; and, sports teams may be honored only in or after their 15<sup>th</sup> reunion year. Exception to this is any team holding a National Championship title shall be inducted as a team in their 10<sup>th</sup> reunion year. Any occasions requesting more than two inductees will require the approval of the President of the College and the VP of College Advancement.
- 5. The President of the college will select the chairman and secretary from the first six (6) positions identified in Paragraph 6.
- 6. The College President, the chairman; the Athletic Director, the VP of College Advancement and the Board of Trustee Athletic Committee Chair will select the Sports Hall of Fame Member-At-Large Members. The Sports Hall of Fame Committee shall be composed of 10 members:

Board of Trustees Athletic Chair
President of the Alumni Association
Athletic Director
VP for College Advancement
College Athletic Committee Chair
Director of Alumni Affairs
Four/Five members-at-large as selected by the College President,
Athletic Director, VP of College Advancement, and the Board of
Trustees Athletic Committee Chair

- 7. Each member-at-large shall serve one year and be given consideration to serve again after two years. Previous year inductees will be given first consideration.
- 8. Election of individual inductees and team honorees shall be made by a majority of the Sports Hall of Fame committee at the annual meeting. Absence constitutes a waiver to vote. You must be present to vote.
- 9. Nominations shall be submitted to the Director of Alumni Affairs, no later than September 15th at midnight to be considered for current year induction. Any nominations received afterwards will be placed on the list for consideration in the following year. All nominations must be accompanied with biographical information, including his/her records and mailed to the Director of Alumni Affairs at 433 West Madison St. Pulaski, TN 38478.
- 10. Nominations will carry forward for 5 consecutive years from original date of nomination.
